Additionally they are to do this only after having prayerfully considered the implications of covenanting before God Himself. Therefore this covenant is not to be entered into lightly. It is not simply a secular contract. It is God, not just RSMI, which will hold the covenanter responsible to keep the tenants of this manuscript.

- I covenant to pattern my life after the qualifications for leadership as outlined in the following verses: 2 Cor. 1:23, 24; 1 Tim. 3:1-7; Ti. 1:6-9; 1 Pet. 5:1-4
- I covenant to honor God's name in all my actions as well as my words
- I covenant to honor the name of the ministry of RSMI by not reflecting poorly on that name or the ministry it represents
- I covenant to serve in the RSMI family of ministries, laying down all personal priorities and goals. Thereby this means that I will make the Sovereign Lord God's purposes my goals, and my priorities shall center in the Lord Jesus Christ and His kingdom. I will do this expecting nothing in return, always endeavoring to glorify His holy name only
- I covenant to stand against corruption in my own life, along with standing against corruption in my family, my ministry, my community, and my nation
- I covenant to remain morally and fiscally responsible in all my dealings whether public or private keeping every relationship and action in the utmost purity
- I covenant to continue to be mutually submitted with the other pastors and agents of RSMI whether local – regional – national – or international, that accountability might be maintained
- I covenant to submit to the directions of the leadership of RSMI as long as those directions do not negate the word of God nor the principles of doctrines as taught by the Lord Jesus Himself which have been passed down through the apostles by the agency of the Holy Spirit
- I covenant to maintain doctrinal purity as defined by the RSMI Statement of Faith
- I covenant to submit to ongoing training whether biblical or otherwise, that I might be fully equipped to serve Christ by serving His people
- I covenant to train and prepare God's people under my care that they might not only have a rich and detailed understanding of the word of God, but additionally, that they then might be set in place finding their position in the body of Christ, released to do the work of the ministry as directed by the Holy Spirit in all humility
- Finally I covenant to honor the foundational documents of RSMI, including The Vision – The Mission Statement The Statement of Faith – and the Ministry By-Laws
